Background:

The Township has had a formal agreement with the Township of East Zorra-Tavistock (EZT) since March of 2017 that recognizes the sharing of Building Department staff between the two Township's. Staff feel that, while the agreement served us well in the past, Blandford-Blenheim now has a fully qualified CBO on staff and can operate effectively on our own.

Analysis/Discussion:

The Township has had a formal agreement with EZT since 2017 to share building department staff. This agreement was put in place largely at the request of Blandford-Blenheim because, at the time, we were having difficulty attracting and retaining qualified staff.

When the agreement started the department consisted of a Chief Building Official who was an EZT employee, a Deputy CBO who was employed by Blandford-Blenheim and an inspector in each of the Township's. At the end of the year Blandford-Blenheim would then compensate EZT half the difference between the CBO wage and the Deputy CBO wage.

From 2017 to 2020 employees came and went and when the current Blandford-Blenheim employee started in January of 2020 the department was comprised of the CBO and Deputy CBO who were both employees of EZT and the one inspector who's an employee of Blandford-Blenheim. In May of 2021 a contractor (Paul) was brought in to provide assistance 2 days per

week and these costs became Blandford-Blenheim's. The total costs of the 2 departments are split evenly down the middle.

In 2022 the amount paid to EZT was \$57,207.24. This was in addition to the \$148,426.88 paid by us directly.

The Township's employee in the arrangement is Ray Belanger. He recently became fully qualified to be a Chief Building Official.

Staff are suggesting that the Township notify EZT that we wish to terminate our agreement. We believe that we are able to operate efficiently if Mr. Belanger were to be appointed Township Chief Building Official and Paul Hillenaar (contractor) were to be appointed Deputy Chief Building Official.

Financial Considerations:

In 2022 the total costs to staff Blandford-Blenheim's share of the building department was:

Blandford-Blenheim 148,426.88 Paid to EZT <u>57,207.24</u>

\$205,634.12

If current Blandford-Blenheim handled Township duties and we were not in that arrangement with EZT our costs could have been similar to the costs actually paid out in 2022 which were \$148,426.88.

These are very rough figures but our savings could have been approximately \$57,000. There are no shared assets which would need to be split amongst the partners.

Being a By-law to appoint Paul Hillenaar as Deputy Chief Building Official for the Township of Blandford-Blenheim pursuant to the provisions of the Building Code Act.

WHEREAS Section 3(1) of the Building Code Act, R.S.O. 1990, Chapter B.13 provides that the Council of each municipality is responsible for the enforcement of this Act in the municipality;

AND WHEREAS Section 3(2) of the Building Code Act, R.S.O. 1990, Chapter B.13, directs that each municipality shall appoint a Chief Building Official and such inspectors as are necessary for the purpose of the enforcement of the Act in areas in which the municipality has jurisdiction;

NOW THEREFORE the Council of the Corporation of the Township of Blandford-Blenheim enacts as follows:

- 1. That Paul Hillenaar is hereby appointed as the Deputy Chief Building Official for the Township of Blandford-Blenheim pursuant to the provisions of the Building Code Act, to provide services under the Building Code Act, as may be required by the Chief Building Official.
- 2. That this By-law shall come into force and take effect on June 12, 2023.
