

Re: Oxford County Council Composition Review

At the regular Council meeting held on April 7, 2022, Woodstock City Council passed the following motion:

"WHEREAS Oxford County Council was required to complete a review of regional council composition following the regular election in 2018;

AND WHEREAS such review must either affirm the current council composition or change the number of members of its council that represent the lower-tier municipalities;

AND WHEREAS any affirmation of the status quo or change in the number of members that represent the lower-tier municipality must be supported through a triple majority approval that includes Oxford County Council and its Area Municipal Councils;

AND WHEREAS Oxford County Council advanced the status quo option through the triple majority approval process and this option failed to achieve triple majority support;

AND WHEREAS Ingersoll Town Council advanced a weighted voting system option through the triple majority approval process and this option failed to achieve triple majority support;

AND WHEREAS the Municipal Act requires the County Council to complete this review with triple majority support within two years commencing the day the new County Council was organized in 2018;

AND WHEREAS the County Council has not complied with this requirement;

AND WHEREAS the Municipal Act prescribes that the Minister may make a regulation changing the composition of County Council if the regional municipality fails to comply with this requirement, only after the expiration of the two year period but before the year of the next regular election after which the regional municipality has a duty to conduct a review:

AND WHEREAS the Minister, in recognition of non-compliance to this requirement, has encouraged Oxford County Council to continue working to reach a local consensus for the composition of its council;

AND WHEREAS the authority under the Municipal Act for the Minister to make a regulation changing the composition of County Council for the 2018 term of Council has expired;

AND WHEREAS the Municipal Act does not require another review of County Council composition until the next regular election in 2026;

AND WHEREAS the Municipal Act requires any regulation made by the Minister to change the composition of County Council to have regard to the principle of representation by population;

AND WHEREAS Census 2021 reveals that the current County Council composition does not have regard to the principle of representation by population with one County Councillor representing a population as few as 7,600 and another County Councillor representing a population of 18,600;

AND WHEREAS for further information, the population representation per County Councillor for each lower tier municipality in Oxford County is as follows:

Town of Tillsonburg - 18,615
City of Woodstock - 15,568
Town of Ingersoll - 13,693
Township of Norwich - 11,151
Township of Zorra - 8,628
Township of East Zorra-Tavistock - 7,841
Township of South West Oxford - 7,583
Township of Blandford-Blenheim 7,565

AND WHEREAS population forecasts indicate that this disparity in representation will be further eroded with the release of Census 2026 and the next required review of County Council composition in 2026;

AND WHEREAS the next opportunity for the Minister to make a regulation respecting County Council composition will be 2028;

AND WHEREAS the failure to comply with the requirement to complete a review of

County Council composition in the 2018 term of Council should not result in the County Council being able to prolong this review as the next deadline in which the Minister may make a regulation respecting County Council composition will be in 2028;

AND WHEREAS the Province has declined to release the recommendations from the Regional Review and that these recommendations could assist with the development of a local resolution to County Council composition;

NOW THEREFORE BE IT RESOLVED that the Woodstock City Council request that the Province impose a deadline for County Council to complete a review of County Council composition, that is supported by a triple majority, no later than two years from the date that the new Council is organized in 2022;

AND FURTHER that the Woodstock City Council request that the Province release the recommendation of the Regional Government review as it relates to Oxford County;

AND FURTHER that this resolution be circulated to the Honourable Doug Ford, Premier of Ontario; the Honourable Steve Clark, Minister of Municipal Affairs and Housing; the Honourable Ernie Hardeman, Oxford MPP; the County of Oxford; and all lower tier municipalities in the County of Oxford."

#### RE: Oxford Road 3/Main Street Reconstruction 2024-2025

We appreciate the concerns that have been raised by Princeton residents following the public meeting on April 21, 2022 for the Princeton Drainage Project with regards to proposed road improvements and lane reconfiguration on Oxford Road 3/Main Street in Princeton.

In response to these concerns, we have provided the following information to demonstrate the rationale and alignment with County-wide principles and strategic initiatives that are intended to improve overall road safety and support active transportation. With that said, we are considering potential alternate solutions to alleviate the concerns raised by residents while at the same time achieving the County's strategic objectives.

#### **BACKGROUND**

Oxford Road 3 (OR 3) is part of the County arterial road network that extends through the urban village of Princeton (Main Street) and was previously identified in the County's long term capital budget for road urbanization (curb/gutter, storm water infrastructure) for the section north of the CN Rail crossing to Roper Street.

Road urbanization of OR 3/Main Street in Princeton is further supported by the 2019 Oxford County Transportation Master Plan (TMP) and is identified as an implementation project as part of the overall road network strategy. This project is also identified in the Development Charges (DCs) Background Study (2019-2023) as it is partially related to future growth and therefore partly funded through DCs.

The Township of Blandford-Blenheim (TBB) recently initiated the Princeton Drainage Project under the Drainage Act that will include municipal drain infrastructure throughout Princeton including on OR 3/Main Street and therefore the County as the road authority is assessed costs as part of the overall drainage project.

The County and TBB are partnering on the Princeton Drainage Project since a significant part of the work will occur on OR 3/Main Street, which has provided an opportunity to complete the road urbanization as a joint project. A similar approach was utilized as part of the Plattsville



Drainage Project (2010-2014) that included full road reconstruction of Oxford Road 8/Albert Street along with Drainage works.

#### PROPOSED CAPITAL WORKS - OXFORD ROAD 3/MAIN STREET, PRINCETON

Full road reconstruction of OR 3 /Main Street will be undertaken in 2024-2025 as part of the Princeton Drainage Project and will include road urbanization north of the CN Rail crossing to Roper Street as previously identified in the County's long term capital plan. The proposed improvements to the existing road cross section on OR 3/ Main Street have been shared with TBB staff for their input and incorporation into the drainage works project.

The Princeton Drainage project is tentatively scheduled to start in 2022 with initial construction works (including municipal drain crossing of CN Rail and stormwater management pond works). Construction within road corridors is scheduled to commence in 2023 and be completed by 2025. Oxford Road 3 reconstruction is scheduled to take place in 2024 (south of CN crossing) and 2025 (north of CN Rail crossing), which will require detailed design to be finalized by the end of 2022.

The planned road reconstruction also includes proposed implementation of cycling facilities (1.5m bike lanes) on each side of OR 3/Main Street, from the south end at Oxford Road 2 to the north end at Roper Street to support the County-wide Active Transportation Strategy.

In order to accommodate cycling facilities on the segment south of the CN Rail crossing to Oxford Road 2, the existing paved shoulder/parking lane would be repurposed for bike lanes; however, on-street parking is proposed to be maintained on the west side of OR 3/Main St. between Elgin St and Railway St. to accommodate businesses in this area. Realignment of curbing is also proposed along the segment south of Elgin St to Oxford Rd 2 that would result in narrowing of the current road platform.

Road urbanization for the segment north of the CN Rail crossing to Roper Street is proposed to include 3.35m travel lane and 1.5m bike lane on each side of the road. On-street parking is not proposed for this section north of the CN rail crossing.

#### SPEED MANAGEMENT AND TRAFFIC CALMING

The key principles of the County-wide traffic calming approach, adopted by County Council in 2019, includes consideration of traffic calming measures as part of road design. Staff was aware of speeding concerns in Princeton and considered potential traffic calming measures as part of conceptual road design for OR 3/Main Street.

A Speed Management and Road Safety Review was recently completed on Oxford Road 2 and Oxford Road 3 in Princeton. The findings and recommendations of this study were presented



to Blandford-Blenheim Township Council on March 16, 2022 by County staff and included immediate and future traffic calming implementation measures.

As part of future traffic calming measures, road urbanization of OR 3/Main Street north of the CN Rail crossing and overall reduced road width were identified. Reduced road width, along with implementation of bike lanes, are intended to promote lower vehicle operating speeds by changing the visual driving environment which largely influences Driver's choice of speed.

#### PARKING ON COUNTY ROADS

The primary function of the County arterial road network is for the mobility of vehicles (cars, trucks, farm equipment), pedestrians, and cyclists, and to provide access to local roads and adjacent properties. Parking is a secondary function and is generally discouraged on arterial roads since parked vehicles can increase the risk of collision by reducing sight lines and opening doors into traffic lanes. In most cases, adjacent properties have adequate off-street parking and it is not a requirement to provide on-street parking. However, designated parking is already provided in some commercial areas, including Princeton, where there may be limited preferences for off-street parking.

#### **ACTIVE TRANSPORTATION STRATEGY**

Implementation of a County-wide active transportation (AT) system is identified in the County's 2020-2022 Strategic Plan as an objective to improve travel options beyond the personal vehicle. To meet this objective the County has undertaken the development of a Cycling Master Plan (CMP) that will guide the implementation of cycling facilities (i.e. bike lanes) on County Roads and to provide AT connectivity between communities, employment areas and tourism destinations.

As part of public consultation through the development of the CMP, the majority of respondents indicated they would be more apt to cycle if appropriate facilities were in place to improve overall safety. Cycling on roadways is a permitted use under the Highway Traffic Act (HTA) except were specifically prohibited (i.e. 400 series highways) and the implementation of onroad cycling facilities will improve safety for all road users and further promote AT.

Historically, the County's cycling policies have included Share the Road signs, wider pavement with a white edge line on rural roads and addition of bike lanes in urbanized areas as part of scheduled road reconstruction activities. The CMP, which is expected to be finalized by the end of June 2022, expands on current cycling policies and has identified primary and secondary cycling routes on the County road network. The proposed primary network provides key east-west and north-south links and connectivity from rural areas to the three urban municipalities (Woodstock, Ingersoll, Tillsonburg). The secondary network is intended to provide additional connectivity from smaller urban villages to the primary network.

Conceptually, the primary network would be implemented over the next 10+ years followed by implementation of the secondary network as the demand increases through greater AT participation. Although Oxford Road 3 is identified as part of the secondary network for future implementation, there is an opportunity now to install bike lanes in Princeton as part of scheduled road reconstruction and at essentially no additional cost since the paved shoulder/parking lane will be repurposed for bike lanes.

#### POTENTIAL ALTERNATE SOLUTIONS

In response to the concerns raised by Princeton residents, we propose the following:

- No change to the existing road width from Oxford Road 2 to CN Rail crossing
- On street parking to be maintained on both sides of the road from Railway Street to Elgin Street
- Existing parking lanes from Oxford Road 2 to Elgin Street will be designated for future bike lanes (in 10+ years)
- Sharrows will be provided to accommodate future cycling from Elgin Street to CN Rail Crossing (Sharrows = shared lane by cyclists and vehicles i.e. single file)
- No change to proposed road cross section from CN Rail to Roper Street (3.35m travel lane and 1.5m bike lane both sides – no on-street parking)
- Parking Study to be completed in Q3 2022 from Oxford Road 2 to CN Rail crossing that will consider need/demand for on-street parking and recommendations for implementation (eg. time of use parking, parking restrictions)




## **CROSS SECTION A-A**

ROPER ST. to RAILWAY ST. SCALE 1:80





#### **Capital**

- Blenheim CN Bridge CN has made the decision to replace the steel bridge structure.
  The bridge deck redesign is complete and the new contractor is building it. Dufferin
  Construction will be doing the install and are expected to have it done by the end of
  2022. There has been some supply chain issues with the steel and this has caused
  another delay.
- Gobles CN Bridge The engineers report is completed and has been reviewed. Dagmar
  is working with CN on a design review, this is expected to take until the end of May (4-6
  weeks) The review is deciding if the structure can be fixed to allow the bridge to reopen
  to full capacity or if the structure will need to be replaced. If a repair can be done, the
  bridge will be fixed and open in 2022. If a replacement is needed, we would be looking at
  construction in 2023.
- Princeton The open house was conducted on April 21<sup>st</sup> at the Princeton Hall. There was a good turn out of residence and staff feels they left with there questions answered. The biggest concern brought up was the redesign of the Main St. Most of the parking is being eliminated in favour of bike lanes on either side of the road. This is an Oxford County design and we've been told that any street redesign on a County road will automatically include bike lanes. The second concern was that we are tearing up the roads and not putting piping in the ground for sanitary sewers. As we know sanitary sewers have been denied by Oxford County. Some questions were, why are we not putting the piping in the ground now anyways. First is, if sanitary sewers were to ever come to Princeton, we don't know what type of system would be installed. The hope is that this system would be a pumped system which uses a small pipe and can be installed by jetting or drilling, so this would cause minimal disturbance to the new infrastructure.

• The Tender was awarded to Finch Auto Group. The 2022 ¾ ton, 4x4 pick up was tendered in April of 2021. Staff has received a build date of May 02, 2022. If it indeed gets built, we could see the truck by the end of May early June.

#### County Shared Service/Road Association/Training

- Shared Services meeting The April meeting was cancelled. With the majority of us attending the OGRA conference during the week of the meeting we felt it best to cancel. We will meet again in May.
- Road Association Oxford County Road Supervisors Assoc. We hosted our first in person meeting since 2020. It was nice to see the suppliers and area staff. DiCan technologies and Cedar Signs did presentations of their new products.
- AORS I attended a BOD meeting on April 10 and the AGM on April 11. AORS is happy
  to announce our trade show scheduled for June 1 & 2 in Barrie will be happening after it
  has been cancelled the last 2 years. AORS also announced the transition back to in
  person training as well as offering some programs in a hybrid format, in person & on-line
  setting.
- 9 staff members attended Trench safety training and 3 staff members attended a grading refresher course. It is nice to see that training is happening again.

#### **Other**

- Spring! Maybe a couple of days! April has been a challenge. Typically, staff have been across all the roads and maybe even graded some twice. We have been dealing with many rain days, snow, sleet, high winds, etc, etc.... Staff is continuing to take things in stride and do what we can when we can. Grading is going well and is ongoing, staff has the equipment ready for calcium and gravel that will start in May. Some ditch and culvert work has been started and will continue through the spring and summer.
- Working with the GRCA on the clean-up of illegal material that was dumped on the closed section of Township Road 2 and trying to clear up what can be done on that property.
- Working with KSmart and Drainage Superintendent on planning the open house for the Princeton project.
- Staff is still continuing to meet with land owners at outdoor sites to discuss ditch or road issues.
- Attended the OGRA conference
- Had 3 days' vacation.

#### THE CORPORATION OF THE

#### **BY-LAW NUMBER 2299-2022**

Being a by-law to provide for the adoption of budgetary estimates and tax rates for 2022, and to further provide for penalty and interest in default of payment.

**WHEREAS,** Section 290 of the Municipal Act, 2001, S.O. 2001 c.25, as amended, provides that the Council of a local municipality shall prepare and adopt estimates of all sums required during the year for the purposes of the municipality,

**AND WHEREAS,** Section 312 of the said Act provides that the Council of a local municipality shall, after the adoption of estimates for the year, pass a by-law to levy a separate tax rate on the assessment in each property class, and

**AND WHEREAS,** Section 307 and 308 of the said Act require tax rates to be established in the same proportion to tax ratios; and

**AND WHEREAS** regulations require reductions in certain tax rates for certain classes or subclasses of property; and

**AND WHEREAS** the Assessment Roll prepared December 14, 2021 and upon which the taxes for 2022 are to be levied, was certified by the Assessment Commissioner, and the whole of assessment for real property, according to the last Assessment Roll, and further modified to reflect changes of the Assessment Review Board, Severances and Section 442 Tax Write-Offs.

**NOW THEREFORE** the Council of The Corporation of the Township of Blandford-Blenheim enacts as follows:

- 1) That the budget estimates setting out the revenues and expenditures as detailed in the Budget Estimates for the year 2022, and endorsed by by-law 2288-2022, February 16, 2022, raising the following amounts from realty taxation be adopted (Schedule "A"):
  - (a) For general municipal purposes the net levy of \$6,140,602;
  - (b) For county purposes the net levy of \$5,714,013;
  - (c) For school purposes the net levy of \$3,245,802
- 2) That the tax rates hereby adopted for each class for the year 2022, excluding special charges or local improvements collected as taxes, shall be the tax rates as listed on Schedule "B" attached hereto and forming part of this by-law and the tax rate for each class shall be applied against the whole of the assessment for real property for that particular class and purpose.
- 3) That in accordance with the Municipal Act, 2001 S.O. 2001 and the Assessment Act, the Treasurer may strike from the roll, taxes that by reasons of a decision under Section 357, 358 or 359 or of a decision of a judge of any court are uncollectible and/or refund any overpayment received.

4)	That every owner shall be taxed according to the tax rates in this by-law. The
	taxes for a particular property shall be calculated by applying the Current Value
	Assessment against the tax rates set out and further adjusted as required by the
	provisions of the Municipal Act, 2001, S.O. 2001. Such taxes shall become due
	and payable in two installments as follows:

#### **ALL PROPERTY CLASSES**:

FIRST INSTALMENT Wednesday, August 31st, 2022

**SECOND INSTALMENT** Monday, October 31<sup>th</sup>, 2022

Notice of such taxes due shall be sent by first class mail (or e-mail if requested) to those persons shown as liable for the payment of taxes.

- 5) That the taxes shall be levied and collected as well as such other rates and/or Special Area Rates, pursuant to the Municipal Act, 2001, S.O. 2001 and/or the Drainage Act.
- 6) That a charge as a penalty of 1 and ¼ per cent on the amount of any outstanding taxes levied in 2022 shall be made on the first day of default and on the first day of each calendar month thereafter in which default continues until December 31st, 2022, and any such additional amounts shall be levied and collected in the same manner as if they had been originally imposed with and formed part of the taxes levied under this by-law. The penalty charges indicated in this section shall be waived for those taxpayers participating in the Monthly Preauthorized Payment Plan provided the payments are made as agreed and without default.
- 7) That interest of 1 and ¼ percent on the amount of any taxes due and unpaid after December 31<sup>st</sup>, 2022, shall be charged on the first day of each calendar month thereafter in which default continues.

This by-law shall come into effect on the date of the final passing thereof.

By-law **READ** a **FIRST** and **SECOND** time this 4th day of May, 2022.

By-Law **READ** a **THIRD** time and **ENACTED** in Open Council this 4th day of May, 2022.
